- 2. This form must be named using the following format: *MRForm_FirstLast_*Videoname (see submission form for the format for naming your video).

EXAMPLE: John Smith appears through audio, video, or photograph in a video on flooding in Houston, TX, produced by filmmaker and corresponding author Jane Doe. John Smith's MR form would be named:

MRForm JohnSmith Houston TX flooding JaneDoe

If it is Jane Doe's MR form, it would be named: MRForm_JaneDoe_Houston_TX_flooding_JaneDoe
