### **INSTRUCTIONS**

- 1. **Submissions are due 11:59 pm, November 15, 2018.** A link will be provided on this page November 15, 2018 where videos and forms can be submitted. Winners will be announced December 14, 2018.
- 2. This form is required for each video that is submitted, as well as media release forms from all individuals appearing in the video. Where required, HIPPA forms must also be submitted (see guidelines form HIPPA requirements).
- 3. Each video should be named using the following format:

**City\_State\_Impact\_FirstLast** (name of filmmaker and contact person)
EXAMPLE: A video on flooding in Houston, TX, by filmmaker and contact person Jane
Doe would be named: **Houston\_TX\_Flooding\_JaneDoe** 

4. This submission form must be named using the following format: **SForm\_Videoname**EXAMPLE using the above video name and scenario for Jane Doe: **SForm\_Houston\_TX\_flooding\_JaneDoe**

## **Submission Check Lists**

### **TECHNICAL REQUIREMENTS**

Video is named according to the format specified above

Video is in MP4 format

Video size does not exceed 200MB

Video does not exceed 2 minutes and 30 seconds, excluding references and credits

Video is filmed in at least 1080p

All media and footage (music, photos, videos, recordings) that is not original is available in the public domain (e.g. government photos, or materials with a creative commons license), and given credit in the production references where required by their creators

All sources have been included in the film credits, and appropriately referenced

#### **FORMS**

Media release forms (yellow form) have been completed and signed by the creators of the video

Any person who appears in the video through video, audio, or personal photographs that are not in the public domain have completed and signed a media release form

Media release forms have been signed by parents for participants under 18 years of age, if applicable

HIPPA release forms (pink form) have been completed and signed by each video participant providing medical information, if applicable

HIPPA release forms have been signed by parents for participants under 18 years of age providing medical information, if applicable

Submission form is completed

Submission and release forms are named using the required format: The file name of video (see instructions above), and with the proper extensions indicating the type of form (SForm—submission form, MRForm—media release form, HIPPAForm—health release form

#### **SUBMISSION**

All necessary forms and the video will be uploaded together as one submission online

Materials will be submitted no later than 11:59 pm, November 15, 2018
